Mr Clive Burnage was invited to describe his role as TALCP Coordinator and explained his aims of assisting Parish Councils to find ways to work together in community partnerships to achieve delivery of proposed projects and services and the 'one-off' funding currently available to Parishes. Cllr Jury is exploring an idea to see if it would be feasible for Dolton to jointly purchase a salt/gritting machine with Beaford Parish using this scheme. Cllr Jury said that this had come up at an Advisory Group Meeting and she had been given a funding claim form which would need to be completed by the Ward Councillor. Cllr Haynes had attended a TALCP meeting and had intended to give a verbal report later in the Agenda but this would not now be necessary. A short question and answer session followed.

235(12/13) PARISH GROUNDS

Cllr Jury asked for the War Memorial stonework and steps to be cleaned and any ivy and weeds removed prior to Remembrance Sunday and it was agreed that the Parish Caretaker should be asked to undertake the task and be paid for the extra work involved. It was also agreed that plants for the pots could be purchased by Cllr Jury.

- (i) Football Field The Clerk has been trying to chase up DCC about the proposed license for the School but cannot get a response as the person dealing with this is away on maternity leave.
- (ii) Dennis Cross. Cllr Dunn's weekly inspections have taken place nothing to report. Beaford Arts Centre will liaise with Cllr Dunn on the siting of the Van for their Letter Box Play event on 6th October. Cllr Dunn suggested that there is insufficient space for the proposed adult exercise equipment on the far side of the field as requested and that instead a wicker fence should be erected to provide privacy from the road for users.

Cllr Jury said that the Jubilee Committee's bulbs were currently being planted in the grass splay from the Dolton sign down and should make a good display. A grant has been applied for to the Lottery Fund towards the purchase of the adult exercise equipment.

It was unanimously agreed that the wall is a great improvement and well constructed. The Clerk was asked to write a letter of thanks to Mr and Mrs Madge for their generosity in supplying the lovely stone without charge and the loan of the safety fencing. Cllrs Haynes and Rolls volunteered to assist Cllr Lock in removing the safety fencing and replacing the soil. The brick splay at The Paddocks to be an agenda item for next meeting.
