#### **PUBLIC SESSION**

## 421(13/14) PLANNING

a) Applications to consider -1/1066/2013/LBC,1/1065/2013/FUL repair and rebuild boundary wall The Old School Cottage - The Council had no objections and approved of an area being made to
park car off the road.

1/0973/2013/LBC – to take down and replace dilapidated link building and reinstate former openings to domestic store building –Arscotts Cottage – no plans were available to view so the Council could not comment.

- 1/0046/2014/LBC repair gable wall and replacement of sash windows 1 Thornes Cottages, West Lane- plans were not available to view so Council could not comment.
- b) Permissions granted none
- c) Permissions refused none
- d) **Local Plan** The Clerk had spoken to Dawn Burgess at TDC who confirmed that the figure of 63 extant building consents in Dolton Village on 1<sup>st</sup> April 2013 was incorrect and an error on the part of TDC. The correct figure should be 14 with 2 under construction. The clerk would highlight this error along with points made at the last meeting in the Councils response to the draft neighbourhood plan. The clerk would also attach a copy of the 'Vision and Objectives' for Dolton Village to the response. A review of the Vision and objectives would be an Agenda item at the next meeting.

## **421(13/14) PARISH GROUNDS**

- a) Football field i) Hard Play Area Sarah Radford from NPS had contacted the Council stating it was not possible to access the football field via the neighbouring property to remove the Hard Play Area. The new plan was to enter the football field with a mini digger, staying off the pitch, and drive around the back of the changing rooms. The digger would break up the hard surface allowing the water to drain freely. The drain serving the hard area would be removed and capped off at the boundary with Mr Madge's land. The broken up play area would be left in situ until the end of the football season and fenced off with heras fencing. This work is due to commence 10<sup>th</sup> February. The Council agreed to this plan. Cllr Rolls agreed to liaise with Peter Baglow the Area Building Surveyor for NPS who was overseeing the project. It was agreed to ask that the Basketball posts on the Hard Area be removed and saved so they could be repositioned on a new site. Phase 2 of the plan would involve the reinstating of the area with soil etc. This would take place at the end of the football season, details to follow nearer the time.
- b) Broken kissing gate Cllr Dunn reported the gate was in manufacture.
- c) Dennis Cross nothing to report
- d) Memorial Garden nothing to report
- e) Football field green space protection the Clerk had circulated information about Fields in Trust who provide legal protection for playing fields. The Council were reluctant to go down this route and it was decided to discuss alternatives with the Solicitor. This would be done when the Council meet with the Solicitor to finalise the new School license. The Clerk would make enquiries to establish the whereabouts of the playing field Deeds.
- f) School rent for football field as the new license was still not in place it was agreed the school should be invoiced the same as last year.

#### **422 (13/14) MAINTENANCE AND TRAFFIC**

- a) **Bus turning** The buses generally seemed to be turning much better now. When the 'Caution Bus Turning' signs arrive councillors will meet to establish where to place them.
- b) Cllr Jury had spoken to the Community Police Officer about the speed of traffic entering the village.

**424(13/14) TAP FUND –** The 12/13 TAP – Booklets were printed and would be circulated at the end of March in time for Easter.

**425(13/14) Meetings attended** – Cllrs Jury and Dunn had attended a recent meeting of Torridge Advisory Council. It was reported that due to budget cuts many unclassified roads may become unmaintained. The Local Plan is unlikely to be ready for consultation until late Spring /early Summer.
