PUBLIC SESSION

The Chairman suspended Standing Orders to invite members of the public to speak

It was reported that people with mobility scooters were unable to access footpath in Stafford Way due to the grid.

There were concerns that the council should not put forward too many sites for development in the local plan. Comments were made that Dolton should remain a village and not become a small town.

345(13/14)LOCAL PLAN

It was explained that following the last meeting the council had consulted with TDC and were advised that if all available development sites were included in the new parish development boundary the village was at risk of overdevelopment. The council had revised the parish development boundary and this along with Dolton's response to the Local Plan was unanimously accepted. – attached to minutes.

346(13/14)PARISH GROUNDS

Dennis Cross- Cllr Dunn reported part of the exercise machine was rusty. He would report to supplier. Strips of rubber would be attached to the gates to stop them rattling.

Memorial garden- Cllr jury requested permission to purchase plants for the planters – granted

Planters on paved area between Paddocks and Union Inn. It was agreed to purchase large barrel planters from MVF along with compost and plants. It was agreed a cheque could be signed for this.
