73(2014/15) MEETINGS ATTENDED – Three members of council plus the clerk had attended the Devon Highways conference held at Clinton Hall on 17th September. Highways face large cuts in their budgets and are keen to promote self-help in communities to deal with issues like sign cleaning, weed pulling, footway cleaning, bus shelter cleaning and grass cutting in low risk areas. They are also keen that parishes should appoint a road warden - similar to the snow warden - who would attend a training course organized by highways and would carry out risk assessments etc for work carried out. More information of Highways self-help and community support was placed in the reading file for councillors to read.
