Any other financial matters: i. On the proposition of Cllr Burnage, Seconded by Cllr Boyes it was unanimously agreed that the Precept for 2011/12 should be set as last year at £12,300.

ii. The TDC budget questionnaire was completed for return to TDC. iii. Cllrs. Lock and Jury, having declared an interest, left the room while the Grant Application for the Village Hall was discussed. **On the proposal of Cllr. Grigg, seconded by Cllr Byrne** it was unanimously agreed to Grant the Village Hall the sum of £1,250 (Ch. No.491).

The Clerk reported a Current acc. bal. of £14,715.90 (less above cheques to be paid) and Dep Acc: £5,556.12.

82(10/11) Planning

- a. Applications to consider –1/0954/2010/FUL Stoney Fields Farm, West Lane Dolton –American style stabling & ménage no objections in principle but request that any planning permission is conditional on private horsicultural use only as any commercial usage of this site would create inappropriate extra vehicular usage of a single track lane.
- b. Permissions granted none
- c. Refusals advised- Wood Farm 1/0269/2010/FUL
- d. To receive any other planning matters: The letter on T&CP Regs. "Scoping Opinion –Solar Park with Photovoltaic Panels Land at OS 258472 115077 Cowflop Cross, Dolton" was discussed. **On the proposal of Cllr Boyes, seconded by Cllr Byrne** the Clerk was asked to request more information from TDC.

83(10/11) Parish Grounds

i. Dennis Cross. The Clerk was asked to request Sutcliffe Play to undertake any necessary remedial work around equipment in accordance with the Zurich Engineering Inspection report at the same time they install the Actizone Compact Climber.

ii. Public Toilets in Square. Cllr Lock had met with the new Landlord of the Royal Oak who at this time is not interested in taking over the cleaning and care of the toilet.

84 (10/11) Parish Action Plan.

Cllr.Burnage gave a verbal update on the work of the Vision Group, the housing survey forms distributed by GM Planning, and expressed his disappointment at the content of the letter from GM Planning requesting extra money to cover the postage costs of the recently mailed housing survey forms. Following a general discussion of the latter it was unanimously agreed that the Clerk should draft a suitable letter of refusal to GM Planning expressing the Parish Council's surprise, anger and disappointment at their request. Cllr Burnage said local landowners would be invited to the next meeting of the Vision Group in January, and that in future all meetings of the Vision Group would be advertised on the Parish Notice-board and an open day is planned for February. He would try to get Mr Bob Patterson to speak at the next Parish Council meeting on 10^{th} January.

It was proposed by Cllr Giles that a large Notice-board for posters advertising all meetings and events in the Village be erected on the brick paved area at The Paddocks to stop the random display of posters on almost all telegraph poles throughout the Village which look untidy. The Clerk to ascertain from TDC if planning permission for the erection of a notice-board would be required. The proposition was seconded by Cllr Jury and carried.

Cllr Burnage thought that in response to the email from CCD asking 'Are you willing to work within a cluster of local councils for representation, service delivery and campaign purposes' the PC should agree to do so and the Clerk was asked to respond favourably but requesting more information.

Feeling unwell Cllr. Grigg left the meeting at 9.30 p.m.

85(10/11) Maintenance and Traffic Issues - To receive updates on local issues.

The Clerk was asked to report water running right across and down the road at West Lane, and Langham Cross to Woolridge Cross and also to ask for the Grit/Salt bins to be refilled as soon as possible.

Cllrs Lock and Burnage together with Ward Cllr Lock had attended the Rural Affordable Housing Conference opened and addressed by Princess Ann at Woolsery on 26th October and each had attended a different workshop and each gave verbal reports. The general opinion was that emphasis should be put on working with the community, that villages should keep growing and national planning policies are changing. Princess Ann was very keen to get people doing things for their community and said because times are hard now communities should get ready to spring into action when money becomes available.
