## **Dolton Parish Council**

# Minutes of the meeting held Monday 9th January 2006 7.30pm in the Village Hall

**Apologies:** there were none

The minutes of the meeting held 5<sup>th</sup> December 2005, having been duly circulated were signed by the chairman as being a true and correct record with the following amendments:-

- a) Min.728: Cllr.Kendrew confirmed that the figure of 75% of households was reported by the Chairman at the last meeting in the absence of Cllr.Silltow. Cllr.Kendrew felt that Cllr.Silltow had made a grave mistake in giving such information. Councillors should strike this figure from their minds whilst discussing the subject of the Design Statement.
- b) Min.733: The Barn London House the word "official" replace the word "informal".
- c) Min.744a: Cllr.Kendrew the chairman of the Steering Committee had made mistakes and there was a conflict of personalities resulting in all the correspondence. He asked the question "should members of DRAG involved in a court case with TDC, go down to TDC to discuss the Design Statement with them?"
- d) Min.744b: to be added at the end "The Chairman had no problem with signing the draft letter to be presented to TDC".
- d) Min.760: "letter to be sent to Cllr.Silltow as Chairman of the Design Statement Steering Committee, thanking him and all committee members, for all their hard work.

Proposed Cllr.Kendrew seconded Cllr.Grigg. All agreed.

## **MATTERS ARISING FROM MINUTES**

- 743. Pavement Arscotts Cottage (min.724 refers) no reply from Mr.Jury for start date. Resolved that Clerk contacts Mr.C.Hodgson of DCC Highways informing him that Mr.Jury was trying to contact him.
- 763. Barlands Rectory Road access (min.725 refers) TDC Enforcement Officer confirmed that gate to be fixed in place will be secured by concreting it to the ground work to be completed by end of Jan.2006.
- 764. Football Field toilet block (min.729 refers) Mr.Levitt confirmed that work will be completed within the next fourteen days.
- 765.MUGA/Skateboard area (min.730 refers) no reply from DCC Education Dept. or solicitor.
- 766. The Barn London House (min.733 refers) letter received from Ms.J.Watts concerning the wording of minute 733. (letter copied for each councillor's information). Minute changed accordingly to read "official complaint" not "informal complaint".
- 767. Footpath Stafford Way/Stafford Road (min.734 refers) no response from TDC. Resolved that Clerk write again.
- 768. Orchard Gate Phase 2 affordable houses (min.734 refers) Clerk spoken to Mr.M.Brown TDC Planning Dept. today 9<sup>th</sup> Jan. who reported that the matter was still in the hands of the solicitors.

- 769. MUGA/Skateboard area (min.757 refers) letter received from Mr.Williams concerning drainage matters, copied to each councillor for their information. Resolved that Mr.Williams proceed with a trial pit as outlined in his letter, obtaining a quote for such work. The cost of this work to be capped at £180.00.
- 770. Highways Matters (min.758 refers) DCC Highways reported that drainage cover will be rectified, and potholes repaired in the near future. Blocked drains will be added to the list. Chapple Cross Langham Road had no accident history that would warrant erection of sign or reflectors. They will monitor the situation.
- 771. Fly tipping Chapple Cross (min.759 refers) TDC had reported on their visit that there was no material tipped. Situation to be monitored.

774. Clerk reported no hours worked for MUGA/Skateboard funding.

# **PLANNING MATTERS**

775. Adjoining Parish notices in reading file.

776. Applications to consider:-

a) Mr.Mrs.Woolrych-Higgins Quiillets North St. 2 storey rear extension. (Cllrs.Kendrew and Chivers declared interests and left the room)

Council had no objection to this application so long as the extension work is sympathetic to the conservation area.

b) Mrs.M.Grigg Tockley Farm Barn conversion to holiday accommodation.

(Cllrs.Lock, Grigg, Chivers and Berkley-Sage declared interests and left the room)

Council had no objection to this application as it fits planning policy, but are concerned about the extra traffic that such work and conversion will create along a long single track lane leading to the property of Tockley.

c) Mr.G.Madge land grid. ref 8183 land use to construct area for private use for horses (amended (Cllrs.Lock and Jury declared interests and left the room) application form)

# PLAY EQUIPMENT DENNIS CROSS

780. Cllr.Kendrew and Clerk produced further details of play equipment for council's consideration. Proposed Cllr.Grigg seconded Cllr.Lock that we immediately purchase the following equipment from Wickstead to be financed from funds held in Portman Building Society Dennis Cross account: All agreed.

781. Resolved that at a later date the Council submit to the school the brochures for "Doing Sport Differently" for children to select their preferred equipment, which would form the plan to be submitted to TDC for the release of £7,500 due to Dolton from Messrs. Saltmarsh and Jury.

## **DESIGN STATEMENT**

782. Cllr.Silltow reported/commented as follows on min.no 744:-

- a) all committee members of the Steering Group were volunteers, and he apologised for late delivery of circular letter.
- b) Committee had not fallen out they discussed disagreements around the table.
- c) They had appointed somebody in house to lead funding "a finance liaison officer". Clerk to the Council would still be the Treasurer.
- d) With regard to Dec.5 minutes and question of 75% of households, he thought he had explained these figures at the meeting of 24<sup>th</sup> November
- a) With regard to the next committee, the Church and Wild Life Trust had already nominated members to serve on this committee. More needed from other local organisations.
- b) Vital Village brochures cost £22.14 to produce. Resolved that these be sold for £23 each plus postage. Still available are 72 doctored versions. Resolved that these be free. This information to be posted on noticeboard
- 783. Meeting arranged with TDC on 17<sup>th</sup> January 2006 2pm. TDC will be represented by Mr.D.Tucker, Conservation Officer, Mr. Bines, Area Planning Officer and Cllr.Mrs Feruson, Ward Member.
- 784. Cllr.Silltow would redraft the letter to be signed by Cllrs.Lock and Silltow to be presented to TDC at this meeting.

785. On a show of hands 5 Councillors, Cllrs.Lock, Silltow, Grigg, Berkley-Sage and Kendrew gave 100% positive backing for the Design Statement.

## FOOTBALL FIELD

786.Cllr.Kendrew stated:-

- a) that the question of Mr. Mrs.Madge's land gift should be left until the planning issues were resolved.
- b) Mr.Williams should be asked to carry out feasibility study on the drainage and resizing of the muga/skateboard areas should the extra land not be gifted.

787.Proposed Cllr. Giles seconded Cllr.Grigg that Mr.Williams be asked to carry out feasibility study as to the drainage and also the resizing of the muga/skateboard areas.

#### **ENFORCEMENT ISSUES**

788. TDC reported that in the absence of an effective enforcement service, the legitimacy of the planning process is itself undermined. TDC is committed to ensuring that effective prioritised enforcement is undertaken. Resolved that enforcement issues will still be dealt with by the Parish Council, but we will encourage individuals to report direct to TDC. Details of the Enforcement Officer to be displayed on noticeboard and diary.

789. Clerk to fix public meeting for all users of the football field to discuss the issue of a deed of dedication for the football field.

## TORRIDGE VOLUNTARY SERVICE

790. Cllr. Berkley-Sage reported on two schemes that operate within the rural community to benefit the 65/75yrs age group, both of which she felt would be beneficial for Dolton. Resolved that we invite a representative from this organisation to a Council meeting to give a presentation of their work.
