18(14/15) CLERKS REPORT- the clerk reported that the 'Bus Turning 'signs were now in place. Concerns had been logged with highways about a subsiding drain in Stafford Way, lack of grass cutting inside the 30 mph sign – including Stafford Way roundabout, and overgrown verges at Dolton Beacon junction. The reply had been that urban grass cutting contractors should be cutting inside the village 4 times a year and concerns about Dolton Beacon had been passed to the contractor.

- c) Updated Financial Regulations and Internal Controls Policy were approved and signed.

The Clerk and made enquiries about alternatives. RSoPA would carry out an annual inspection in March each year for £65 + vat for up to 5 items + £3 for each additional item. This would cost the Council approx. £95 + vat . The clerk would check this did not compromise the Councils insurance cover and if acceptable cancel the inspection part of the contract with Zurich.
