Minutes of Council meeting held Monday 14th May 2007 immediately after the AGM

The minutes of the meetings held 2nd April and 18th April 2007, having been duly circulated were signed by the Chairman as being a true and correct record. All agreed.

MATTERS ARISING FROM MINUTES 2nd APRIL

445. TDC Housing Dept (min.406 refers) letter and housing form now received by Mr.Glover

- 446. Hectors Close (min.411 refers) The chairman of Dowland Parish Committee had reported to the Clerk that the Village Hall Committee should be writing to him enquiring about funding, not the Parish Council.
- 448. Annual Parish meeting (min.414 refers) Clerk confirmed that Mrs.Lesley Smith of DAPC would attend this meeting. This would not be treated as a training session and she would still expect new councillors to attend training sessions. She had requested some ideas of "bullet points" for discussion. Clerk handed to councillors agendas for Parish Meeting.
- 449. Rubbish Chapple Cross (min.437 refers) Cllrs.Grigg and Berkley-Sage reported that a bag of rubbish had been dumped today ie. Monday 14th May. They will ascertain a name and inform the Clerk.
- 450. Arden House (min.438b refers) Mr.Nimmo reported that building work had ceased on the conservatory and he was awaiting clarification from TDC as to the way forward.

- 454. Village Green Cllrs.Berkley-Sage, Giles and Jury ordered copies of Village Green at a cost of £6.50 per annum.
- 455. Councillors wishing to sign council cheques were asked by the Clerk to take personally into any branch of Nat.West. a form of id. plus a utility bill. Clerk to obtain form for signature by councillors.

PLANNING MATTERS

456. Adjoining parish notices in reading file.

457. Applications to consider:-

a) Mr.Mrs.B.Searle Youldons single storey front extension (Cllr.Lock declared an interest – relative – and left the room)

Council had no objections to this application.

b) Mrs.G.Crisp Cartlinhay conv.of garage to sitting room with roof lights.

Council had no objections to this application and were pleased to note their comment on the position of the window had been noted, and the new pitch of roof is now more in keeping.

c) Mr.Mrs.Jenner Parsons 1 Hackwills removal of conv. & erection of single storey extension.

Council made the following comments:-

- i) should be a listed building application to consider at the same time, the property being a Grade 2 listed building
- ii) the access at the rear of the property for neighbours must be retained.
- iii) has the adjoining owner been notified of this application?
- iv) Parish Council note that the footprint for the extension appears to be considerably larger than the existing conservatory, and not as stated on the application "similar to the footprint"
- v) the property is in a conservation area.

CODE OF CONDUCT/TRAINING FOR NEW COUNCILLORS

461. Parish Council will have to adopt the revised code by October 2007. After that time members of Councils that have not adopted the revised code will be automatically covered by it.

- 462. TDC will be providing training for the new code shortly.
- 463. Clerk highlighted two new options for Parish Councils:-
- a) have regard to advice from Monitoring Officers and Financial Officers and give reasons for all decisions.
- b) members can attend meetings where they have prejudicial interests in order to make representations/answer questions and then withdraw from the meeting.

Council discussed these two points and felt that both were improvements but b) should not be abused and be closely monitored. Resolved that the adoption of the revised code of conduct be an agenda item next meeting.

464. Training - Cllrs.Boyes and Burnage would attend a day on 11th June in Bideford and Cllr.Genge may attend on 21st June in Newton Abbot. Clerk to arrange. Resolved that cost per delegate of £45 be split 50/50 between council and councillors.

465. Council resolved that a review of the Parish Plan may be a better way forward

initially – to be an agenda item next meeting.

FOOTBALL FIELD

466. Chairman reported that Football Club had grass seeded parts of the pitch and carried out ancilliary work.

467. Cllr.Jury reported as follows:-

- a) a final layer of tarmac to be layed Wed.16th June weather permitting.
- b) should the insurance company be informed of completed work?
- c) resolved that Cllr.Jury proceed with the second phase of the work ie. grants for new play equipment.
