CLERK'S REPORT ON ADMINISTRATION OF DOLTON PARISH COUNCIL AFFAIRS 2017/18

Accounts

A summary of income and expenditure and bank reconciliations has been circulated with explanatory notes.

Assets

An internal controls policy is in place and attached to this is a Register of Assets owned by the Council. This year the car park has been completed, and the Air Ambulance Landing Lights and the Defibrillator have also been added to the Asset Register. Deeds of property owned are with solicitors Trowers & Hamlins LLP, The Sennate, Southernhay Gardens, Exeter EX1 1UG

Borrowings

At close on 31/3/2018 the Council had no outstanding borrowings

Leases

At the end of the year the council had entered into no new leases

Debts

At close of business on 31/3/18 the Council had no debts outstanding

Tenancies

The football club pays a nominal rent of £5 per annum ground rent for the changing rooms. The playing field has been rented by Devon County Council for use by Dolton Primary School for £250/per annum. The Primary School will convert to Academy Status in September 2018 and a new agreement between the Multi Academy Trust and the Parish Council has been drawn up.

Donations

Dolton and Dowland Village Hall – for car park opening ceremony £100.00
