7 (19/20) TO CONSIDER PLANNING MATTERS

- a) Applications to consider: 1/0248/2019/AGMB. Stoney Fields Farm, West Lane, Dolton. Concerns were raised because the proposed development lies outside the building development area, and it was agreed to raise a question about agricultural permitted development as this appears to be an equine site. A question was also raised about the size of the holding site and whether this may have a bearing on the permitted development. Concerns were also noted about the traffic impact on West Lane, being mindful of the other developments currently being undertaken.
- **b)** Applications granted there were none
- c) Application withdrawn there were none
- d) Applications refused there were none
- **e)** Any other planning matters.

Representation at the Plans Committee on 4th April to consider the Small Wind Turbine at Eastlake Farm. It was agreed that Cllr Rendell would attend and read a statement from the Parish Council in support of this planning application.

8 (19/20) PARISH GROUNDS. Matters Relating to:

- a) Car Park. i) Deed of Easement: Village Hall Legal Costs. It was agreed that the Parish Council would pay the Village Hall legal costs which had been estimated at £500 plus fees.
 - ii) The chain across the car park entrance has been installed and thanks were expressed to James Kendrew for his work with this.
- b) Football Field. A meeting between all parties had been held and it had been agreed to conduct a feasibility study to identify possibilities, perhaps creating more flexible internal arrangements. Cllr Rolls will explore the possibilities with a representative from the football club and a possible future user.
- c) Dennis Cross. The Inspection Report has been received. There are several items now in need of attention.
- d) Memorial Garden. Nothing was reported.
- e) Half Barrel Planters. The requests for sponsorship had resulted in a good response, with £425 already received.
- f) Telephone Box. It was agreed that this would be an agenda item next time so that arrangements to convert it to an information point could be planned.

- a) Speed signs on Rectory Road. Cllr Rendell reported that another quote is being sought to ensure best value. It was confirmed that it will be sited on land that does not belong to Highways.

- **d)** Defibrillator. The Infant Pads have been installed.
